## Overview

### EOL14621 - Amended

Cisco announces the end-of-sale and end-of-life dates for the Cisco 1000 Series Connected Grid Routers. The last day to order the affected product(s) is December 30, 2022. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin.
