Cisco announces the end-of-sale and end-of-life dates for the Cisco CRS 400G FCC Fabric Card CRS-FCC-SFC-400-B End-of-Sales Announcement. The last day to order the affected product(s) is March 2, 2020. End-of-Sale Date: HW	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	March 2, 2020
Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	May 31, 2020
End of Routine Failure Analysis Date: HW	The last-possible date a routine failure analysis may be performed to determine the cause of hardware product failure or defect.	March 2, 2021
