Cisco announces the end-of-sale and end-of-life dates for the Cisco NCS-5011. The last day to order the affected product(s) is February 25, 2022. Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	February 25, 2022
