

End-of-Sale and End-of-Life Announcement for the Cisco Nexus 3132Q Switch (40 GE)

Cisco announces the end-of-sale and end-of-life dates for the Cisco Nexus 3132Q Switch (40 GE). The last day to order the affected product(s) is October 20, 2016.
